ADVOCACY – Speaking up for Low-Income Missourians

Legislative Update

The Senate and the House got back to work following break and the historical filibuster over SJR 39. There are concerns that some bills still on calendars could slow the Senate down again but at this point, their work is moving forward. We continue to stay very engaged in the appropriations process with several of Community Action Agencies' core funding line items moving forward.

Appropriations

The Senate Appropriations Committee finalized its budget recommendations. A conference committee of Senate and House members will have to determine the final amount for budget items on which the Senate and House disagreed. One item that will go to conference is the subsidies for child care providers for low-income children and their families. Our budget priorities, including the following, have all been included in the budget up to this point:

- Community Services Block Grant
- Low-Income Home Energy Assistance Program (including the transfer to the Low-Income Weatherization Assistance Program)
- Early Childhood Education- State Early Head Start
- Utilicare

Earned Income Tax Credit

Efforts to establish a state Earned Income Tax Credit continue to move forward, although the pace has slowed significantly. HB 1605, Representative Kelly's bill to establish a State Earned Income Tax Credit was reported to pass and will move on to the Senate. There is still opposition on the tax credit. However, it has received more bipartisan support than in recent years which makes us hopeful we can keep it moving.

Temporary Assistance for Needy Families & Supplemental Nutrition Assistance Program

We continue to monitor several bills that would have an impact on the Temporary Assistance for Needy Families (TANF) program and the Supplemental Nutrition Assistance Program (SNAP). Some of the bills we are monitoring deal with establishing a farmers market program for seniors, eligibility determination, and a joint committee on public assistance.

Medicaid Expansion

A new study was released by the U.S. Dept. of Health & Human Services showing Medicaid expansion could greatly improve access to behavioral health services. Even in light of these reports, the General Assembly refuses to have the debate to close the coverage gap through expanding Medicaid.

Marketplace Fairness

Also of interest to our Network, the Marketplace Fairness Act has moved forward with the passage of SB 795. The bill would make changes necessary for Missouri to join the Streamline Sales and Use Tax governing board. Membership would trigger about 2,500 out-of-state retailers to voluntarily collect and remit use tax on their sales from Missouri purchasers, like brick-and-mortar retailers currently do, thus reducing the competitive disadvantage for in-state retailers.

Approximately \$15-20 million would be collected every year, with the additional funds to be used to provide increases for childcare provider rates.

2016 Community Action Advocacy Day

On March 16, members of the Missouri Community Action Network gathered at our State Capitol to show that "Community Action Cares" at our 2016 Advocacy Day. During the event, members participated in a rally, met with legislators and showcased their innovative agency programs through exhibits.

During the rally, we discussed the Community Action Network's legislative priorities- strategies to address poverty in Missouri- within the five elements of poverty: Education, Housing & Energy, Food, Family &

Economic Security, and Health. We also had an incredible opportunity to hear from three constituents who shared their personal stories, and discussed the impact that Community Action has had on their lives.

The event was a great success! 100% of participants said they were able to meet with legislators and it was a great way for them to advocate on behalf of low-income people. Agency staff were able to share how our Network helps families reach self-sufficiency, provides emergency services to stabilize families in crisis, and mobilizes communities to come together to fight the causes and conditions of poverty!

The Missouri Kids Count Data Book was released on April 5. The *Missouri KIDS COUNT Data Book* is a collaborative project of the [Family and Community Trust \(FACT\)](#), [Children's Trust Fund \(CTF\)](#), the [Office of Social and Economic Data Analysis \(OSED\)](#) at the University of Missouri, and more than 20 public and private organizations across the state. CTF and the [Annie E. Casey Foundation](#) provide the primary funding for the data book and data tool. The mission of the *Missouri KIDS COUNT Data Book* is to improve the well-being of Missouri's children and families. MACA serves as a member of the Kids Count Advisory Committee.

Results Oriented Management and Accountability (ROMA) Next Generation

The ROMA Next Generation initial feedback period ended on April 1, 2016, which was on a tight timeline. This feedback period will be followed by the OMB clearance process, which will allow additional time for comment. The OMB clearance process will include an initial 60-day public comment period, and a final 30-day comment period. NASCSP will make changes to ROMA Next Generation documents, tools, and reports based on the Network's feedback and prepare for submission to OCS for the OMB Clearance Process.

MACA staff will be outlining the changes and feedback during the April Internal ROMA Consultant Professional Alliance. Please stay engaged in the feedback process as we move forward. Detailed and specific comments are especially critical at the early stages of the process to ensure that the documents are as strong as possible and allow us to showcase the work of Community Action at all levels of the Network.

MIS Request for Proposals (RFP) Update

The Family Support Division (FSD), in conjunction with the Missouri Community Action Directors Association (MCADA), has asked MACA to conduct a competitive search for a statewide software solution. This request comes as the state is reviewing software systems across the state, and it has been more than 12 years since a competitive search was conducted for our CAA software. MACA convened an Onboarding Team with representatives from all 19 CAAs, the FSD office, MCADA, and the MACA office. A formal RFP was distributed in March, with an April 6th response deadline.

We are happy to report that we have received 10 proposals, including one from our current provider, Adsystem. The Onboarding Team is in the process of selecting the top three candidates, which will then receive further scrutiny from our statewide team in the coming months.

Project Management: A Critical Factor for Sustainability

Whether you're working on a grant, a fundraiser or an outreach event, getting staff and volunteers on the same page is critical for success. One way to improve communication and ensure staff understand their roles, specific tasks and deadlines is to use a project management methodology.



The Project Management Institute (PMI) definition of a project: "A project is **temporary** in that it has a defined beginning and end in time, and therefore defined scope and resources...a project is unique in that it is not a routine operation." Project Management is then defined as the application of knowledge, skills, tools, and techniques to project activities to meet the project requirements. It also ensures projects end on time and within budget.

At MACA, we are piloting a new web-based project tracking tool on some of our projects. This tool is free for groups of 15 or less. Check it out and consider a pilot in your agency. In the event there are ten or fewer nominations for the At-Large positions, then no election will be held and the MACA Board of Directors will vote to seat the nominated candidates. In the event there are more than ten nominations for the ten At-Large positions, then there will be an election by the Individual Membership with the process to be determined by the MACA Board of Directors.

Caring for Missouri Masquerade Ball & Charity Auction – Funds Now Available for CAAs

We were pleased to finalize our role as the fiscal agent for the Network's first statewide fundraiser. You can download the final report on the event website at: <http://caring4missouri.org/blog/>. In summary, we raised \$178,077 and after expenses, each charity received \$47,649.81 to use for their specific causes. In MACA's case, we have those funds reserved for use by the Network for three areas. The MACA board approved the funds to be used

for educational scholarships for out-of-network training, for special technical assistance needs for agencies to hire consultants and trainers, etc., and for additional Moodle courses to be developed and accessible by the entire Network. 
